NOTICE:

POST SIGNS: The following signs must be posted at each location where fireworks are sold.

- 1. "No Smoking"
- 2. "Must be at Least 18 Years of Age to Purchase Fireworks"
- 3. Approved signage (attached) that indicates dates and times of allowable fireworks possession and use
- 4. Exits in tents
- 5. City and State License

OTHER REQUIREMENTS: The following requirements must be adhered to, if applicable.

- 1. If stand is electrically "hard wired" an electrical permit will be required.
- 2. All temporary access points onto City roadways shall be returned to original state upon removal of stand.
- 3. If tent is used, inspection and permit must be obtained by the Las Cruces Fire Department.
- 4. Waste (boxes, paper, etc.) capable of becoming wind borne shall be contained daily by either a fenced enclosure or removed from premises.

ACKNOWLEDGMENT: (Please initial by each statement)

_____ Only fireworks as allowed within NM State Statutes shall be sold at this location.

_____ No bottle rocket or stick-type rocket shall be sold from this location in accordance with City of Las Cruces Municipal Code.

_____ A fire extinguisher, a minimum of 2-A per 500 square feet of stand size, shall be maintained and kept at the location in working condition and serviced within one year.

_____ The stand, tent or temporary structure shall be placed, to meet the following distances:

- (a) 50 feet from flammable liquids,
- (b) 25 feet from a permanent structure on the same property,
- (c) 25 feet from a designated parking area as identified on the site plan,
- (d) 15 feet from all property lines,
- (e) Distances required by the building code and/or fire code adopted by the City of Las Cruces.
- _____ Discharging of fireworks shall be prohibited within 150 feet from any location where fireworks are sold.
- _____ Electrical wiring is to be maintained in a safe and hazard free condition.
- _____ Fireworks may not be sold until the time all applicable inspections have been conducted and approval has been granted by the appropriate City departments.

This acknowledgment form is required for approval for all fireworks locations for the City of Las Cruces. By completing this form, the applicant/business owner hereby acknowledges and understands, and will comply with the regulations for conducting fireworks sales in accordance with the City's Municipal, Zoning and Fire Codes. Applicant/property owner may be subject to misdemeanor prosecution for any violation of these regulations which may result in the fireworks stand license being REVOKED. ALL LOCATIONS WHERE FIREWORKS ARE SOLD ARE SUBJECT TO INSPECTION AT ANY TIME.
