### **NOTICE OF FUNDING AVAILABILITY (NOFA) REQUEST FOR PROPOSAL (RFP) APPLICATIONS**

CITY OF LAS CRUCES (CITY) PROGRAM YEAR PY2025  
COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG)  
HOME INVESTMENT PARTNERSHIP PROGRAM (HOME)

The City is announcing the start of the application cycles for PY2025 CDBG and HOME programs. These federally funded programs are used by the City to provide decent housing, a suitable living environment, and the expansion of economic opportunities principally for low-income persons or families.

The City anticipates receiving the following grant amounts from the U.S. Department of Housing and Urban Development (HUD) for the PY2025: CDBG \$1,056,272 and HOME \$490,236.

For an activity or project to receive consideration for application, an **RFP-Letter of Intent (LOI) must be completed** by the non-profit organization or sponsoring agency and submitted to the Housing & Neighborhood Services section no later than **Monday, September 23, 2024, 4:30 p.m.**

#### **PY 2025 RFP-LOI WILL BE AVAILABLE Thursday, September 5<sup>th</sup>, 2024**

CDBG and HOME applications will only be accepted from eligible 501(c)(3) non-profit organizations, government entities, and qualifying grantees.

The City is required to prepare and submit to HUD a one-year Action Plan that provides detailed information on the activities that the City will fund with CDBG and HOME funds for the PY2025. The City will conduct public meetings on the proposed One Year Action Plan during March, 2025. City Council will approve the final one-year action plan in May 2025.
